For the Johnson & Johnson vaccine, I understand that at this time, the Johnson & Johnson COVID-19 vaccine requires 1 dose. For Moderna & Pfizer vaccine, I understand that at this time, the Moderna & Pfizer COVID-19 vaccine requires 2 doses given 21-28 days apart depending on the manufacturer. If this is my first dose of the COVID-19 vaccine, I intend to receive a second dose of the same vaccine in accordance with the timeframe specified in the Fact Sheet to complete the vaccination series.

I agree to stay in the vaccine administration area for fifteen (15) minutes or longer if indicated by the vaccine administrator after receiving my vaccine to ensure that no immediate adverse reactions occur.

I understand that I will be receiving the vaccination at no cost to me.  
 If **insured**, please bring in your prescription and medical insurance cards for your vaccine appointment. I authorize the pharmacy to bill my insurance on my behalf for the immunization – understanding I will not incur any costs.

If **uninsured**, you must check the box below to attest that the following information is true and accurate:
